

## **Introduction to 2010 Directory of Districts**

### **The Soil and Water Conservation Districts**

A soil and water conservation district is a political subdivision of the Commonwealth responsible for conservation work within its boundaries. A district focuses attention on land, water and related resource problems; develops programs for solving the problems; and coordinates assistance from public and private sources to carry out conservation programs.

When the Soil Conservation Districts Law of Virginia was passed in 1938, the foundation was laid for today's 47 soil and water conservation districts. Other states throughout the country have established similar organizational structures, and there are now nearly 3,000 soil and water conservation districts nationwide.

Districts provide local citizens with the opportunity to shape resource planning in their communities. While receiving technical and financial assistance from local, state and federal sources, soil and water conservation district boards make the decisions, set the priorities and make sure conservation occurs.

This cooperative process helps districts control soil erosion, prevent flood water and sediment damages, and promote agricultural and urban conservation. Through memorandums of agreement with other agencies, districts help to preserve wildlife, protect the tax base, and enhance the health, safety and welfare of the people. In addition, districts sponsor community events, such as field trips or demonstration projects, working with citizens at a grassroots level to create awareness and understanding of conservation needs and measures.

Members of district boards are called "district directors" and are local citizens, landowners, and resource managers who are familiar with area environmental conditions. All directors serve without pay.

### **The Virginia Department of Conservation and Recreation, Division of Soil and Water Conservation**

The Virginia Department of Conservation and Recreation is the agency mandated by the Code of Virginia to provide assistance and coordination to Virginia's 47 soil and water conservation districts located throughout the state. Staff located in Richmond and eight regional field offices assist districts, administratively and financially, in developing and executing sound resource management programs. The Department is Virginia's lead agency in the management and control of nonpoint source (NPS) water pollution.

In addition to conducting programs aimed at NPS prevention, the Department oversees state parks and natural heritage preserves among its many responsibilities.

## **SWCD Director Elections and Appointments**

### **ELECTED SWCD DIRECTORS:**

Beginning in the year 2003, the election of district directors shall be held at the November 2003 general election and each fourth year thereafter. The terms of office of elected district directors shall begin on January 1 following the November general election.

### **APPOINTED SWCD DIRECTORS:**

- Appointments made by the Virginia Soil and Water Conservation Board (Board) to the at-large director position held by a Virginia Cooperative Extension (VCE) agent on every SWCD board shall be made to commence January 1, 2005, and each fourth year thereafter.
- Appointments made by the Board to the other at-large director position (non-VCE agent) for every SWCD shall be made to commence January 1, 2007, and each fourth year thereafter.
